# Letter from the President

This year, AIPPI Congress returns to London for the first time in over 3 decades. That will be the biggest, but certainly not the only, highlight for 2019. I hope many of you have already renewed your membership for 2019 and, if not, you are about to do so!

It has been another extraordinary year for AIPPI UK. We have held a series of engaging and informative events, had a major part to play in developing IP law and policy, and encouraged younger members to get

more involved in the IP world. We have just passed 500 members for the first time, vividly demonstrating that the UK intellectual property profession is truly engaging, welcoming, and outward-looking on national and international levels . I hope you enjoy these highlights of the past and coming year.

# **2018 EVENTS DIARY**

inter: We kicked off the annual study questions with studies in January on conflicting patent applications, protection of 3D trademarks, partial designs and joint liability for IP infringement: Around 60 members were involved, with 38 contributing to the final reports. Many thanks to Bird & Bird for hosting the event. The UK reports formed part of comparative law study in over 40 countries and fed into AIPPI's resolutions at the Cancun Congress, and we have since presented them to the UK IPO. In February, Professor Lionel Bently spoke at an event kindly hosted by Bristows on Registration, Notice and Property Definition in IP Law. As always, Lionel's talk was inspirational, creative and exceptionally insightful.

pring: In March, Roger Wyand QC was again the speaker at our annual review of soft IP developments in an engaging presentation kindly hosted by Hogan Lovells. AIPPI UK made submissions in the Spring to the UK Government on the impact of Brexit on IP, on the Trade Secrets Directive Regulations, and on proposals for the Hague Choice of Court Convention (HCCH), met with IPO in preparation for the London Congress in 2019, input to further proposed AIPPI resolutions on inventor remuneration and on the HCCH project, and started participation in the Department of International Trade's IP interest group.

ummer: Our summer season was very busy, with three events in June. Anthony Tridico's talk on the Hatch-Waxman legislation in the US, kindly hosted by Kilburn & Strode, was a great hit. Talks from in-house counsel always provide valuable insight and that was certainly true of the presentation by former General Counsel of ARM Phil David who spoke to us at Bird & Bird's lovely offices, chaired by retired Patent Office guru Sean Dennehey CBE. We made a substantial submission to the Government consultation on the implementation of the Trade Mark Directive, and finished June with our ever-popular summer party hosted at Norton Rose Fulbright's spectacular roof garden. In July we were honoured to hold an event at the world-leading Francis Crick Institute, where Professor Adrian Hayday spoke to a packed and enthralled audience on immunosurveillance in cancer treatment.

utumn: Our Autumn season started with two rapid responses, in rapid succession. In November, Richard Vary and Professor Sir Robin Jacob looked in detail at the Court of Appeal judgment in Unwired Planet. We have had a talk from the same multi-disciplinary panel—patent attorney, solicitor and barrister—on each instance of Lyrica and in December we heard from Claire Baldock, Brian Cordery, and Stuart Baran on the Supreme Court decision. Christmas was not far away when we reach the now-traditional review of the patents year, and we were delighted to welcome back Andrew Lykiardopoulos QC for a veritable feast of intellectual goodies, accompanied by Hogan Lovell's splendid mince pies and mulled wine.

**London 2019** AIPPI UK, and its Congress Coordinating Committee, chaired by Calum Smyth of Barclays, have been working hard towards making this the best Congress ever. This will be a major event in the international IP calendar and should be an important opportunity to showcase the UK as a world centre for IP.



#### POLICY DEVELOPMENT

AIPPI UK has been actively involved in policy development over the past year including making major submissions to the UK govern-

ment / IPO on Brexit and IP, the revision of the Hague Convention on Recognition of Judgments, the UK Trade Secrets Regulations, and UK implementation of the EU Trade Mark Directive. We participated in the Department of International Trade's ongoing engagement with IP interests, and input

informally into many other studies and consultations.



## **CANCUN CONGRESS 2018**

The UK Group's 2018 events calendar alone made for a very active year, but that's not the full picture. Many UK members also attended the annual AIPPI Congress in Cancun, which proved a great opportunity to network and learn. The UK group is among the most active at Congress. This year, there were 1 UK speakers including on the particularly popular artificial intelligence, Brexit and equivalence panels and throughout the phar-And as usual, the resolutions passed at Congress were greatly shaped by the UK group, before and at Congress.

#### **CALENDAR FOR 2019**

AIPPI UK will be running a full calendar of events for 2019 before and after the London Congress. Registration is already open for this year's kick-off meeting for the study questions —and as there will be up to three prizes this year for the best contribution from a younger member, we particularly encourage younger members to participate. This committee work included work on three further areas of comparative study, on the use of post-filing data in support of inventive step/non-obviousness, the HCCH project, and inventor remuneration (the first two of which led to AIPPI resolutions in Cancun).
